On the well-being side, for those countries which have implemented a framework, an inventory of the domains covered (compared to those identified by OECD) is provided. Also, domain by domain, the indicators included in the frameworks are listed, with the aim of identifying possible indicators which the different national frameworks have in common.

For the SDGs, as there are already several country specific, UN based, Eurostat based data bases, with this work it is provided an up-to-date list of web links, for each country. The information is given separately for links providing background information on the advancement of the Country on the implementation of the SDGs and for links containing data on SDGs indicators.

On the well-being side, for those countries which have implemented a framework, an inventory of the domains covered (compared to those identified by OECD) is provided. Also, domain by domain, the indicators included in the frameworks are listed, with the aim of identifying possible indicators which the different national frameworks have in common.



## **2. Sustainable development goals**

The excel file attached “D1.2 links SDGs” contains, for each country in the EU, two sets of information:

- a list of web links containing information on the advancements in the implementation of the SDGs in that country;
- a list of links to data for the SDGs indicators, for those countries where the indicators have been calculated and made available on the national websites.



### 3. Well-being domains and indicators

The excel file attached “D1.2 well-being domains and indicators” contains, for each country in which a framework to measure well-being was implemented, two sets of information:

- an inventory of the domains defined by the country to study the multidimensional concept of well-being, compared to the domains set by the OECD How’s Life? Initiative (OECD (2017). How’s life? 2017: Measuring well-being, OECD Publishing, Paris. [http://dx.doi.org/10.1787/how\\_life-2017-en](http://dx.doi.org/10.1787/how_life-2017-en));
- an inventory of indicators, with the aim of identifying possible indicators which the different national frameworks have in common.

The table is intended as a guide to compare among different countries domains and indicators on well-being.

The domains used by countries for the measurement of well-being were analysed in comparison to the domains suggested by the OECD in the How’s life initiative: Housing; Income; Jobs; Community; Education; Environment; Civic Engagement; Health; Life Satisfaction; Safety; Work-Life Balance.

The topics proposed by the OECD are covered in almost all countries.

Not all countries share a separate domain for “Housing”, however several countries included indicators on the topic but classified them in different domains (among them Material living conditions in France, Slovakia and Poland, Economic well-being in Italy and Social exclusion in Lithuania).

Also the OECD domain on Work-Life Balance is not covered in every country, in some cases indicators on this topic are included anyway in other domains, more related to Job in general, or to leisure time.

It is interesting to note how, in some cases, similar indicators are classified differently in different countries. It is the case for instance of the indicator on persons not in education, employment or training (neet), considered sometimes under the Job area and other times under the education area.

Some countries identify domains which are unique and in some cases testify specificities of the country. It is the case for example of Italy, where two different domains are proposed: Landscape and cultural heritage and Innovation, creativity and research. In Germany the domain “At home in urban and rural areas” was added; in Belgium three additional domains, on climate, energy and Land and ecosystems, are proposed; and “Culture” in Finland.

The analysis of indicators used for each country shows first of all a numeric eterogeneity, ranging from 7 indicators proposed by Hungary to 129 indicators used in the Italian project on well-being (Bes).



This inventory allows to identify which are the indicators most frequently used to measure well-being in the 19 countries where a framework on well-being was developed. In some cases these are the indicators proposed by OECD, which are probably also the most easily available in different countries, but there are a few examples of indicators which appear widely used in well-being frameworks and are not included in How's life by OECD. This is the case, for example, of the indicators on early school leavers, long-term unemployment, population at risk of poverty, income inequality, generalized trust and satisfaction with leisure time.

#### **4. Conclusions**

This guide is an useful tool, which will be used to identify data sources and indicators to be used in the packages devoted to the development of the methodologies (WP1, WP2 and WP3).
